# Item No. 4: To consider and decide communication received dated 2/3/2020 received from Vamanrao Ithape B.Sc. Nursing College, Sangmner.

In the meeting dated 7/2/2020 fees for the A.Y. 2020-21 was approved at Rs. 62,000/-. Accordingly, adhoc fee was reduced. In the review application decided on 27/2/2020 the fees for A.Y. 2020-21 was modified and increased to Rs. 80,000/- In this view of the matter the college is entitled to collect adhoc fees of Rs. 70,000/- in the A.Y. 2018-19 & Rs. 75,000/- in the A.Y. 2019-20.

Therefore, adhoc fees of Rs. 70,000/- for A.Y. 2018-19 & Rs. 75,000/- for A.Y. 2019-20 shall stand confirmed.

# Item No. 5: To consider and decide communication received dated 27/12/2019 received from Jhulelal Institute of Architecture, Nagpur

In the A.Y. 2017-18 approved fee structure was Rs. 1,20,000/-. The college did not submit fees proposal for A.Y. 2018-19 & 2019-20. For A.Y. 2020-21 fees proposal was submitted & fees has been approved at Rs. 1,00,000/-. The college has requested for the declaration of fees for the A.Y. 2019-20.

Having regard to the fees of Rs. 1,00,000/- approved for the A.Y. 2020-21, and the fees for previous A.Y. i.e 2017-18 being Rs. 1,20,000/-, fees for A.Y. 2019-20 shall be Rs. 1,00,000/-.

### Item No. 6: In the matter of Janta Nursing School, Wardha for finalization of fees structure for A.Y. 2019-20.

For A.Y. 2017-18, approved fees was Rs. 42,000/-. For A.Y. 2018-19 the college opted to retain same fee structure. For the A.Y. 2019-20 no proposal was sent & therefore no fee structure was approved. The hard copies of the proposal is submitted by the college. It is perused. Since, the college deliberately failed to submit fees proposal for A.Y. 2019-20 within time, they are supposed to retain the fees of previous academic year i.e. Rs. 42,000/-. Thus the fees for A.Y. 2019-20 shall be Rs. 42,000/-.
